As on the date of this letter, we hold 2,28,40,544 equity shares of the Company, representing 15.61% of the total paid-up equity share capital of the Company.

We are making this request because we are no longer involved in the day-to-day management, affairs, or decision-making processes of the Company. Further, we do not exercise, directly or indirectly, any control over the Company's operations and not associated to with any person or entity classified as "Promoter and Promoter Group".

in support of this request, we hereby confirm and declare as follows:

- We do not hold any Key Managerial Personnel (KMP) position or any executive role within the Company or its subsidiaries.
- We do not have any special rights in the Company through any formal or informal arrangements, including any shareholders' agreements.
- We do not have any representation on the Board of Directors of the Company (including as a nominee director).
- We confirm that we meet and will continue to meet all applicable regulatory conditions prescribed for reclassification from promoter/promoter group to public category.

We request the Board of Directors to review this application, place it before the Board at the upcoming meeting for consideration and approval, and thereafter take necessary steps to seek the required approvals from the shareholders and the relevant stock exchange(s) where the Company's shares are listed, as may be applicable.

We are willing to provide any further declarations, affidavits, undertakings, or supporting documentation as may be required by the Company and/or the regulatory authorities to facilitate this process.
